<u>Facility Description</u>: Applicant applied to the New York State Office of Renewable Energy Siting (Office or ORES) for a permit pursuant to Executive Law § 94-c to construct and operate a 60-megawatt (MW) solar energy facility known as the Shepherd's Run Solar Farm located in the Town of Copake, Columbia County. The facility would include, but is not limited to, photovoltaic ("PV") solar panels; inverters; security fencing; access roads; a substation; and a point of interconnection ("POI") with the Craryville 115 kilovolt (kV) substation owned by New York State Electric and Gas Corporation (NYSEG).

Applicant filed the application with the Office on March 8, 2022. A notice of complete application was issued on August 25, 2023 (see https://ores.ny.gov/permit-applications, click on Project DMM Matter Number 21-02553).

ORES staff published draft permit conditions on October 24, 2024. The draft permit conditions may be accessed at https://ores.ny.gov/permit-applications, click on Project DMM Matter Number 21-02553.

ORES Staff Position: On issuing the draft permit conditions, ORES staff takes the position that the proposed facility, together with the uniform and site-specific standards and conditions contained in the draft permit condition, would comply with applicable laws and regulations. ORES staff recommends that the Office elect not to apply, in whole or in part, any local law or ordinance that as applied to the facility is unreasonably burdensome in view of the Climate Leadership and Community Protection Act targets and the environmental benefits of the proposed facility.

<u>Virtual Public Comment Hearings</u>: Public comment hearings pursuant to 19 NYCRR part 900 to hear and receive unsworn comments from the public will be held before an Administrative Law Judge (ALJ) on Thursday, January 11, 2024, at 1:30 PM and 6:00 PM. The hearings are being conducted electronically through the Webex Events platform and by telephone.

Each public comment session will begin with a brief presentation about the project by applicant. The remainder of the sessions will be devoted to receiving public comments on the application and draft permit conditions.

In addition to the two virtual hearings, four in-person public comment hearings are also scheduled for 1:30 PM and 6:00 PM on Tuesday, January 9, and Wednesday, January 10, 2024. In addition, a written public comment period and the issues determination procedure on the application and draft permit conditions have been initiated for the facility. For information about how to attend the in-person public comment hearings, submit written comments, and participate in the issues conference and any adjudicatory proceedings conducted on the application, please see the combined notice of availability of draft permit conditions, public comment period and inperson public comment hearings, and commencement of issues determination procedure posted at https://ores.ny.gov/permit-applications, click on Project DMM Matter Number 21-02553.

All persons, organizations, corporations, or government agencies who may be affected by the facility are invited to attend the hearings and comment on the application and the draft permit conditions. Instructions on how to attend the hearing electronically or by telephone are provided below. Lengthy comments will not be accepted and instead should be submitted in writing. Equal weight will be given to both oral and written comments. To ensure that all interested persons have an opportunity to speak, the ALJ may limit the time available for oral comments to three (3) minutes per person. It is not necessary to repeat oral comments at each of the hearing sessions. The ALJ will give priority to persons who have not spoken at a prior in-person or virtual session to assure that all interested persons are heard. The public comment hearings will be transcribed for inclusion in the administrative record.

Because the hearing is being conducted electronically, it is reasonably accessible to persons with a mobility impairment. Interpreter services shall be made available to deaf persons, and English language translator services shall also be made available, at no charge for either service, upon written request to Chief ALJ James T. Any person wishing to provide a public statement must register in advance of the hearing no later than 10:00 A.M. on Wednesday, January 10, 2024. Any person who wants only to observe the hearing online must also pre-register. Any person may listen to the hearing by phone without pre-registration.

<u>To register electronically</u>: Persons who will login to a hearing electronically must register. To register, visit https://www.webex.com, click on "Join a Meeting," input the meeting number listed above, click "Register," and fill in the requested information. You will be asked

whether you wish to make a public statement or not. After registration is complete, you will receive a confirmation by email with information about how to join the hearing.

To ensure that all interested persons have an opportunity to speak, the ALJ may limit the time available for oral comments to three (3) minutes per person. The hearing will be stenographically recorded for inclusion in the record.
